

ELECTION INFORMATION AND CANDIDATE NOMINATION PROCEDURE
For Pauma Valley Roadway Association

The Annual Membership Meeting of the Pauma Valley Roadway Association (Association) will be held on April 9, 2024. At the Annual Meeting, a vote will be held to elect two (2) Directors. Voting will take place by secret ballot. An Inspector of Election has been appointed by the Board to manage the election. ***Please notify the Inspector if corrections should be made to the name and/or mailing address on the envelope used for this mailing to ensure that you receive a Ballot package.***

Volunteering to serve on the Board can be a very rewarding experience. It is an opportunity to have influence over decisions affecting the community. In order to be eligible to serve on the Board, each candidate must: 1) be current in the payment of regular and special assessments; 2) not have a past criminal conviction that would prevent the Association from obtaining or maintaining fidelity bond coverage; 3) not be a joint owner of a unit owned by another candidate or Director 4) be in compliance with the CC&R's and all other governing documents; and, 5) Must be a member of the Association. The following is the timeline for the election:

January 2024	Mailing of Election Information, candidate nomination procedure and Candidate Nomination Forms to all owners.
February 15 2024	Deadline for submission of Candidacy Forms and corrections to voter mailing list.
March 9, 2024	Mailing of Notice of Annual Meeting, ballots, submittal envelopes, candidate statements and notice of "Meet-the-Candidates" event; Election Rules to be posted or included in ballot packages.
April 9, 2024	Date of Annual Meeting and election.

Attached below is a **Candidate Nomination Form** that will be used for nominating candidates for the open Directors' positions. The form may be submitted by any Member of the Association to nominate him/herself or another Member. If you are interested in being a candidate, please complete the Candidate Nomination Form and return it to the Inspector of Elections by first-class mail, for receipt by the deadline noted below. By submitting the Candidate Nomination Form, you are certifying that you meet the eligibility requirements listed above. If you wish to nominate another Member, please first make sure that he or she is willing to serve.

If you are nominating yourself to be a candidate for the Board of Directors, please complete this form and return it by the deadline. You may attach a one-page candidate statement briefly describing your qualifications, reasons for wanting to serve on the Board and any other pertinent information that will introduce yourself to the other homeowners. Any candidate statement must be limited to a single page (on one side) with not less than 11-point font. The Association will not edit or redact any content from your statement but may include a notation specifying that the candidate or Member, and not the Association, is responsible for the content.
